

## INCLUDING THE FOLLOWING PRODUCTS

### Artista® CE875 Instant Financial Issuance System with Embossing Module

## INSPECTION OF PRODUCT UPON RECEIPT

The following warranty applies to your Entrust Artista® CE875 Instant Financial Issuance System (“Instant Financial Issuance System”).

You must examine all components of your Instant Financial Issuance System immediately upon receipt. If any component is missing, damaged or visibly defective, you must notify Entrust or the Entrust authorized service provider who sold you the Instant Financial Issuance System, within thirty (30) days from the date of delivery of the Instant Financial Issuance System. If you fail to give notice as required, you will be deemed to have accepted the Instant Financial Issuance System and waived any claim you may have against Entrust and/or the Entrust authorized service provider with respect to damage or defects discoverable at delivery.

## PRODUCT WARRANTY

Entrust warrants that a new Instant Financial Issuance System will be free from defects in materials or workmanship for a period of thirty-six (36) months from the latter of (i) date of the date of shipment from Entrust, or (ii) with proof of purchase, the date of purchase by the End User Customer. The warranty for a factory refurbished Instant Financial Issuance System is ninety (90) days.

If the Instant Financial Issuance System proves to be defective in materials or workmanship during the warranty period, Entrust will at its option either repair or replace the Instant Financial Issuance System or refund its purchase price. Any new Instant Financial Issuance System that is repaired or replaced under the warranty will be warranted for the longer of the remainder of the original warranty period or ninety (90) days. A factory refurbished Instant Financial Issuance System that is repaired or replaced under the warranty will be warranted for the remainder of the original warranty period.

All Instant Financial Issuance Systems or Instant Financial Issuance System components replaced under warranty will become the property of Entrust.

## PRINTHEAD WARRANTY

Entrust warrants that the thermal printhead delivered with your Instant Issuance System (“Printhead”) will be free from defects in materials or workmanship for the life of the Instant Issuance System, subject to the below exceptions.

If the Printhead proves to be defective in materials or workmanship during the warranty period, Entrust will at its option either repair or replace the Printhead or refund its purchase price, pro-rated to reflect wear and tear. A Printhead that is repaired or replaced under the warranty will be warranted for the life of the Instant Issuance System.

All Printheads replaced under warranty will become the property of Entrust.

## EXCEPTIONS

Instant Issuance System or Printhead replacements, repairs, adjustments or parts replacements that are the result of (i) accident, abuse, misuse, use in an unsuitable operating environment, unauthorized modification or maintenance (damaged printheads including printheads with pits, gouges, excessive buildup of dust, dirt, or debris, or other evidence of neglect may not be covered due to abuse), (ii) the use of peripherals, supplies or software that are not provided by Entrust, or (iii) recommended maintenance and cleaning of the Instant Issuance System not being followed, are not covered by the warranty and will be charged using Entrust then-current rates. All parts replaced under warranty will become the property of Entrust.

## WARRANTY RETURN PROCEDURE

In order to make a warranty claim, you must first contact either Entrust (see below) or the Entrust authorized service provider noted on the packing slip. You will be responsible for packaging the warranted item and for the cost of freight and insurance to ship it to the designated Entrust or authorized service provider location. Entrust or the authorized service provider will bear the cost of freight and insurance to return the item to you.
